Authorization to Issue Passwords: At the direction of any person named above as your Company Administrator (hereinafter defined), or at the direction of any person named as your Company Administrator (hereinafter defined) in the future, you hereby authorize the Company Administrator (hereinafter defined) to issue one or more passwords for use with the Bank's Internet banking network, as set forth in the Agreements. Customer's designated Company Administrator shall have the sole authority and discretion to determine which individuals (each, a "User") will be authorized to use the Bank's Internet banking network on Customer's behalf. The Company Administrator shall also have the sole authority and determination to designate a User Administrator, which shall have the authority to set Limits (hereinafter defined) for each User, but who will not be able to make any modifications with respect to its own Limits (hereinafter defined) or with respect to the Company Administrator. The Company Administrator shall have no limitation on its ability to utilize the Bank's Internet banking network, but the Company Administrator must set limits (the "Limits") on each User's authority to utilize the Bank's Internet banking network, including, without limitation, each User's access to Company's information and each User's ability to conduct transactions on behalf of Company. The Agreements may be amended or modified (collectively, the "Changes") from time to time at the sole and exclusive discretion of the Bank. Customer's continued use of the Bank's Internet banking network after any such Change shall constitute Customer's acceptance of such Change. The Agreements shall remain available in the principal office of the Bank during the Bank's normal business hours. It is the sole and exclusive responsibility of Customer to obtain current Agreements reflecting each Change. COMPANY ASSUMES FULL, COMPLETE, AND SOLE RESPONSIBILITY FOR THE ACTIONS OF ITS COMPANY ADMINISTRATOR AND THE ACTIONS OF EACH USER, INCLUDING, WITHOUT LIMITATION, THE AUTHORITY GIVEN BY THE COMPANY ADMINISTRATOR TO EACH USER. COMPANY SHALL NOT HOLD THE BANK RESPONSIBLE FOR ANY ACTION TAKEN BY THE COMPANY ADMINISTRATOR, ANY USER ADMINISTRATOR, OR ANY USER, AND COMPANY FULLY AND FOREVER WAIVES ANY CLAIMS, DEMANDS, CAUSES OF ACTION, AND DAMAGES AGAINST BANK DUE TO, RELATED TO, ARISING OUT OF, OR OTHERWISE CONNECTED WITH AN ACT OR OMISSION OF THE COMPANY ADMINISTRATOR OR AN ACT OR OMISSION OF ANY USER ADMINISTRATOR OR AN ACT OR OMISSION OF ANY ONE OR MORE USERS.
